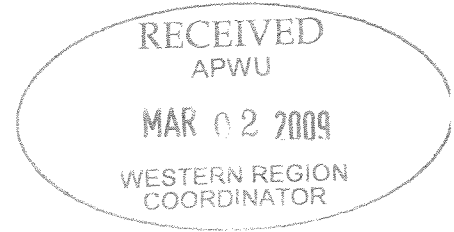

Dear Mr. Gonzalez:

This is to advise you of plans to terminate the lease and close the facility, Denver Mail Processing Annex (MPA), 20101 E. 36<sup>th</sup> Drive, Aurora, CO 80011-8153. The expected lease termination date is February 17, 2010.

We anticipate the functions currently located at the MPA will be moved to the Denver Processing and Distribution Center and/or the Denver Bulk Mail Center, which may result in reduction of staffing and potential reassignment to other installations of APWU represented employees.

We will provide more information as it becomes available and will provide further notice as required by Article 12.

Dear Ms Borsick:

The Portland Local was issued a letter signed by you addressed to me dated 3-12-09 advising of impacts in Portland P&DC, Hood River, Woodburn, St. Helena, Salem P&DF, Medford, Eugene, Monmouth, Sherwood, Ashland, Battle Ground OR plus Vancouver and Longview WA. **The Regional APWU has not received this letter!**

On 3-09-09 a letter from you was received regarding the Seattle P&DC workload reductions and another letter to advise of impacts in Missouli [sic] and Kalispell MT due to workload reductions.

On 3-6-09 I received a letter advising of Impacts for Kalispell, Missoula, Bozeman, Butte, Helena, Harve, Great Falls, Miles City and Billings MT post offices addressed to the NALC. On the same day I received a letter addressed to NALC for impacts in Moses Lake and Oak Harbor WA. **Are these missent or is there an intended radius that impacts the APWU?**

Also on 3-6-09 I received a letter dated 2-27-09 of advance notice that MPBCSs would be removed from Twin Falls, ID. Similarly on 3-06-09 I received a letter to advise of impacts in Billings MT.


On March 4, 2009 a letter was sent regarding plans to terminate the lease of the Denver MPA and on March 4, 2009 advance notice letter was received that an MLOCR will be removed from Elko, NV.

On March 4, 2009 a letter was received that Alaska District was performing customer service work load reviews in Anchorage, AK.

In regard to the above "letters":

- The JCIM reassignment rules require meetings.
- Field Managers/supervisors are not to be discussing these matters with employees until the area/regional parties have held discussions.
- The notice to the regional union is in the form of an Impact/Work Hour Report not letters.
- The Union is entitled to any reports/studies of operational changes or reassignments are planned.
- No Withholding has been declared for the above by the Area VP.
- No Radius has been declared for the above by the Area.
- No information has been provided that indicates what action will be taken to minimize the impacts or what the impacts will be. This does not serve as "Official Advance Notice."

What is the intent of those letters? What is the timeline? What is the impact? What is the radius? When was this plan initiated? When and where can we meet?

Thank you for your response. The purpose of the Events Calendar is supposed to serve as information of potential impacts. Most of the offices you identify in the recent rash of letters are NOT reflected in the January 30, 2009 Events Calendar issued to the Region by the Area Office.

You state the letters are advance notice but not instead of required notices. I take this to mean they are not official notices am I correct in this understanding of your action? You also did not response to our bulleted concerns.

Also, it appears you are issuing letters based on Districts and/or Performance Clusters when in fact most of the offices you identify are not "bid clusters" but appear to be distinct Installations. I look forward to your response after your meeting with the NBA.
