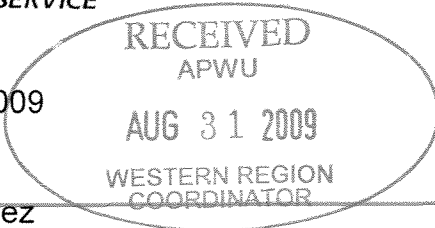

This letter is with regard to the Las Vegas NV CFS Consolidation to the Salt Lake City and Phoenix CFS units. In order to minimize impact due to the workload reductions we are authorizing the withholding of thirty four (34) residual vacancies at the same (Levels 6 and 7) or lower level in surrounding installations within 100 miles of the Las Vegas, NV Post Office. These positions include clerk, carrier, mail handler and custodial craft positions.

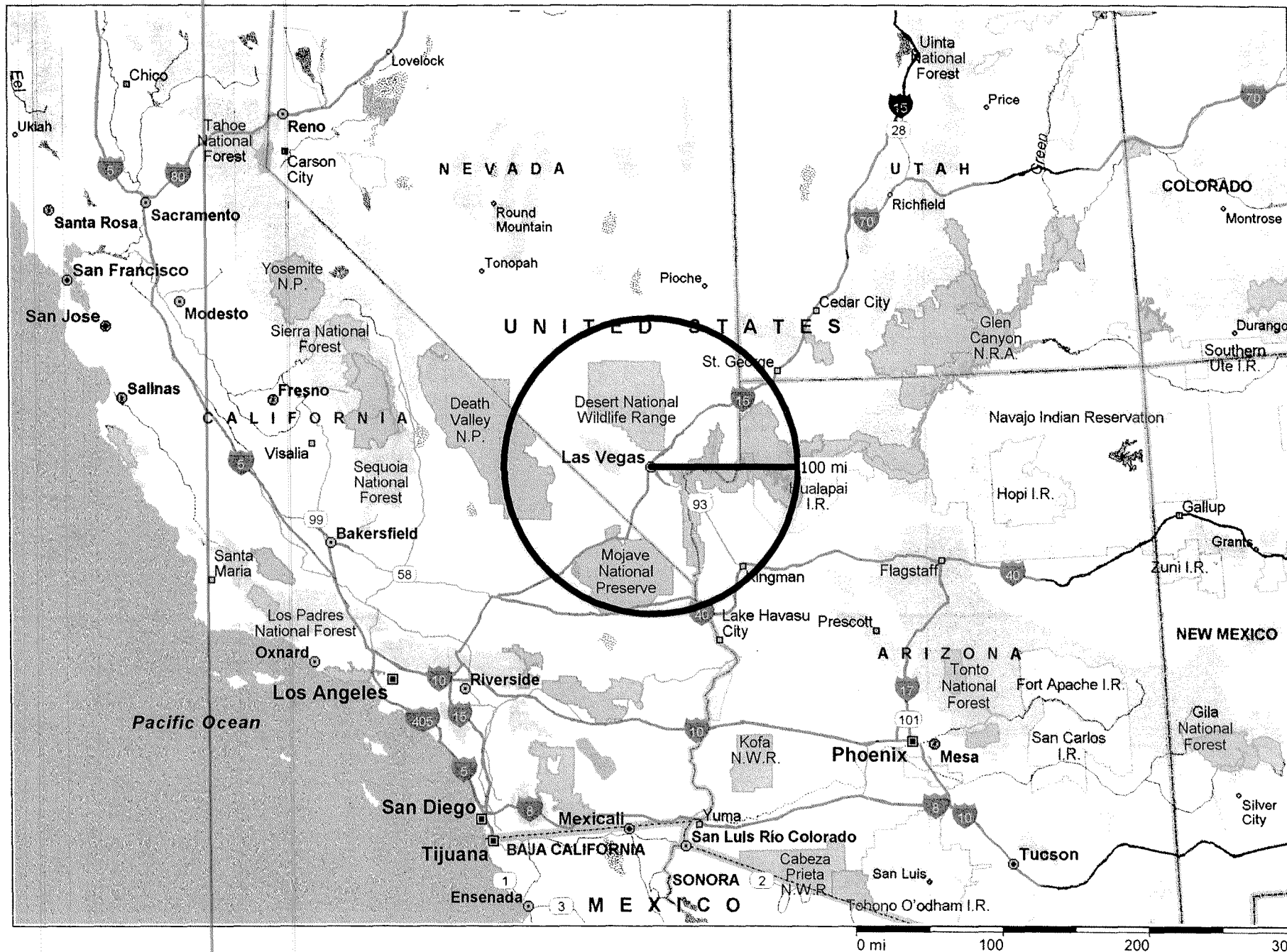
