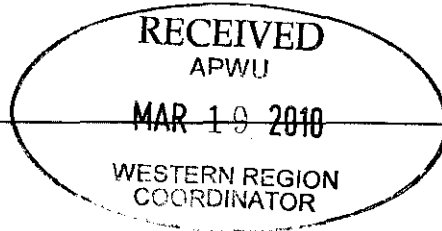

This is to advise you of the intent of the San Diego District to utilize the provisions of Article 12.5.C.5 of the National Agreement to involuntarily reassign up to twenty six (26) full-time clerks and one part-time flexible clerk from the craft and/or installation at eleven (11) separate offices. The specifics as to the number of impacted clerks by office are set forth below:

The impacted employees will be notified of their involuntary reassignments by separate letter. The final placement date would normally not occur until September 16, 2010; however, based on the loss of volume nationally and the financials of the company, it may be necessary to begin the placement process earlier than that date. It may also be necessary to detail some or all of the impacted employees during the notice period in order to provide them with a work opportunity.
