Re: Notice to Amend Withholding Arizona District (corrected)

Dear Regional Union Representatives:

Please be advised of the following amendment to the prior withholding authorization of June 14, 2007 for Scottsdale, AZ Post Office. The previous notice authorized withholding for 8 mail handlers. Based on recent Function Four reviews it was determined that there is not consecutive 4 hours mail handler work in the Scottsdale Post Offices. Therefore, it will be necessary to excess 15 FTR mail handlers. The Arizona Performance Cluster is authorized to withhold 15 FTR positions level PS-4 and below in the mail handler and maintenance crafts (custodial) within a 35-mile radius from the Scottsdale Post Office.

Additionally for the same reason it will be necessary to excess up to 8 FTR mail handlers and 1 PTF mail handler from the Mesa, AZ Post Office. The Arizona Performance Cluster is authorized to withhold up to 8 FTR positions and 1 PTF position, level PS-4 and below in the mail handler and maintenance (custodial) crafts within a 35-mile radius from the Mesa, AZ Post Office.
